1. Purpose of the research

In week 14: Session 2 (max. 7 minutes)

1. You will fill out a short questionnaire.

In week 16: Session 3 (max. 10 minutes)

- 1. You will fill out a short questionnaire.
- 2. You will be debriefed.

4. Possible advantages and disadvantages

We cannot confirm that, if you agree to participate in this study, you will personally receive any direct benefit from your participation in this study. There are also no disadvantages associated with this study.

5. If you do not want to participate or want to stop the research

You decide whether you will participate in the research. Participation is voluntary. If you do not want to participate, this does not have any negative consequences for you. If you do participate, you can always change your mind and quit, even during the research. You can do so by letting the researcher know by email (mvdsalm@student.ou.nl) or closing out the experiment during the experiment. You

do not have to explain why you quit. The data collected up to that moment may be used for the research.

6. End of participation

7. Use and storage of your data
